SUBJECT: October special meeting

Board members:

This is a single item meeting, the sole focus being (hopefully) approval of a resolution authorizing execution of a contract with California Department of Boating and Waterways so that RBRA can receive Abandoned Watercraft Abatement Fund (AWAF) funds for the abatement of abandoned vessels. There is nothing new about the grant process, RBRA has been using the financial assistance provided by a succession of such grant contracts for years, and this is merely the latest one.

One discussion sub-item is new as it potentially relates to the grant acceptance process. In recent years it has become increasingly difficult for Staff to predict when Abandoned Watercraft Abatement Fund (AWAF) grants will become available. This is due in part to the almost yearly budget impasses of varying durations at the State, and the unfortunate shorter time periods within which the funds must be spent. In an effort to get ahead of the feast or famine cycle with respect to these grants, Staff is recommending the Board consider passing at their next (November) hearing a resolution authorizing the acting Board chairman to execute future AWAF grant contracts on behalf of the RBRA, and the Harbor Administrator to perform such work as is necessary to get the grant contract ready for signature. Recognizing that this policy matter should best be considered by the full Board at a regular meeting, Staff is putting a draft resolution example for Board members to discuss at this special meeting.
